SUBJECT: LAFCO File 2014-0003 – East Lake and West Lake RCD Consolidation and formation of the Lake County RCD

EXECUTIVE OFFICER'S RECOMMENDATIONS: Adopt the proposed resolution 2016-0006 approving LAFCO Project 2014-0003 thereby approving the <u>Dissolution of the East Lake Resource Conservation District and the West Lake Resource Conservation District and concurrently forming the Lake County Resource Conservation District (reorganization) consistent with the Sphere of Influence adopted on July 16th, 2014 (Resolution 2014-0006). The consolidation is consistent with the existing district boundaries of the West Lake Resource Conservation District and the East Lake Resource Conservation District. These two RCDs include the entire Lake County and together are coterminous with the Lake County Boundary.</u>

A Concurrent Resolution of Application (Attachment A - Resolution 2016-0001) from the Boards of Directors East Lake Resource Conservation District and the West Lake Resource Conservation District requesting dissolution of their respective districts and concurrent formation of the "Lake County Resource Conservation District" as a successor agency was submitted to LAFCo.

Suggested Motions:

Adopt Resolution 2016-0006 approving the dissolution of the East Lake Resource Conservation District and the West Lake Resource Conservation District and the coterminous and contiguous formation of the Lake County Resource Conservation District.

I. BACKGROUND:

A. Summary:

The East Lake Resource Conservation District and the West Lake Resource Conservation District have jointly made an application to LAFCO to dissolve their respective districts and to concurrently form the Lake County Resource Conservation District located and coterminous with the boundaries of Lake County. The Boards of Directors of East Lake Resource Conservation District and the West Lake Resource Conservation District approved a concurrent resolution on January 25, 2016 requesting LAFCo to initiate proceedings. Since services are already provided within the territory the East Lake Resource Conservation District and the West Lake Resource Conservation District found this reorganization is exempt from CEQA pursuant to Section 15320 of the State CEQA guidelines (Class 20 Exemption) because the proposed consolidation is a reorganization of local government agencies where the changes do not change the geographical area in which previously existing powers are exercised.

East Lake Resource Conservation District (ELRCD) was created in the late 1950s. West Lake Resource Conservation District (WLRCD) was created in November 1959. The creation of both Districts predates LAFCO legislation. The Districts are addressed jointly in this report as both Districts rely on the same District Manager. The West Lake Resource Conservation District and East Lake Resource Conservation District are involved in addressing the resource needs of the County. A Resource Conservation District may make surveys, do research, provide information and plans, and assist landowners with materials, equipment, and labor with respect to soil and stream bank erosion control, water conservation and distribution, and the general enhancement of lands. It may cooperate and contract with other agencies and, with the consent of the landowners, make improvements and conduct operations on private and public lands.

B. Proposal and Justification

The purpose of the dissolution and the formation of the Lake County Resource Conservation District are included in Attachment B (The Plan for Services). These attachments include the services to be provided, the range of services, the extent to which these services can be extended into the affected territory, financial information and the proposed actions being proposed as follows:

- 1. Dissolve the East Lake Resource Conservation District.
- 2. Dissolve the West Lake Resource Conservation District.
- 3. Form the Lake County Resource Conservation District

Staff recommends that the Lake Local Agency Commission approve items 1-3 stated above including the establishment and dissolutions of the two Resource Conservation Districts and the concurrent formation of the Lake County Resource Conservation District subject to the terms and conditions stated in Resolution 2016-0006.

C. Location:

The territory proposed to be reorganized generally extends within the entire Lake County boundaries including its communities.

D. Purpose:

The overall purpose, as stated by both district boards of directors, is to achieve greater economy and efficiency in providing RCD services for resource conservation issues. The East and West Lake Resource Conservation Districts have determined that it is in the best interest to consolidate to better provide services to the residents and landowners throughout Lake County.

K. Existing and Proposed Service Agencies:

All County, District and City services will remain the same excepting the East Lake and West Lake RCD's will be combined under the Lake County RCD.

L. Governing Law and LAFCO Policy

LAFCO is charged with applying the policies and provisions of the Cortese-Knox-Hertzberg Act to its decisions regarding annexations, incorporations, reorganizations, and other changes of government. LAFCO's review of projects must be consistent with the policy directives of the LAFCO Act. Specifically, LAFCO's policies are designed to:

- a) <u>Provide Information</u>. Give applicants for changes of organization guidance as to the information LAFCO needs to make appropriate determinations concerning their applications and provide information and notice to elected officials, governmental staff, and members of the general public as to the standards and procedures that LAFCO will use in evaluating applications.
- b) <u>Set Criteria.</u> Provide applicants for changes of organization with explicit guidance as to the criteria LAFCO will use in approving, disapproving, amending, or conditionally approving applications for changes of organization.
 - c) Ensure Greater Consistency in LAFCO's decision-making process.
 - d) <u>Facilitate Communication</u> among local agencies in the region.
- e) <u>Minimize Adverse Impacts</u> of the social, economic and environmental results of growth.
- f) <u>Provide for Planned, Well-Ordered Efficient Urban Development Patterns</u> with appropriate consideration of preserving open space lands within those patterns.

Concurrent Resolution of Application

By The East Lake Resource Conservation District and The West Lake Resource Conservation District Resolution No. 2016-0001

A CONCURRENT RESOLUTION OF THE BOARD OF DIRECTORS OF THE EAST LAKE RESOURCE CONSERVATION DISTRICT AND THE WEST LAKE RESOURCE CONSERVATION DISTRICT CONSTITUTING THE DISTRICTS' RESOLUTION OF APPLICATION TO THE LAKE LOCAL AGENCY FORMATION COMMISSION TO INITIATE PROCEEDINGS FOR THE CONSOLIDATION OF THE EAST LAKE RESOURCE CONSERVATION DISTRICT AND THE WEST LAKE RESOURCE CONSERVATION DISTRICT

Recitals:

WHEREAS, the Boards of Directors of the East Lake Resource Conservation District ("RCD"), located in Southeastern Lake County, California, and the West Lake RCD, located in Northwestern Lake County, California (the Parties) desire to initiate a proceedings pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, Division 3 (commencing with Section 56000) of Title 5 of the Government Code ("Cortese-Knox-Hertzberg Act") with the Lake Local Agency Formation Commission ("Lake LAFCo") for the Consolidation of the RCDs as specified herein; and

WHEREAS, the Parties have agreed to initiate the Consolidation with Lake LAFCo by adoption of this concurrent resolution; and

WHEREAS, Government Code section 56853 provides in part that, in the case of a concurrent consolidation, Lake LAFCo shall approve, or conditionally approve, the proposed Consolidation; and

WHEREAS, notice of intent to adopt this Concurrent Resolution of Application has not been given to Lake LAFCO, or to any interested agency or subject agency; and

WHEREAS, this proposal is consistent with the Spheres of Influence for the East Lake and West Lake Resource Conservation Districts; and

WHEREAS, the boundaries of the territory included in the consolidated RCD will be the combined territories of the East Lake RCD and the West Lake RCD, as described in Exhibit "A", attached hereto and incorporated herein by this reference; and

WHEREAS, the territory included in the consolidated RCD is inhabited, as defined in the Cortese-Knox-Hertzberg Act; and

WHEREAS, the following agencies would be affected by the proposed jurisdictional changes:

- 1. West Lake Resource Conservation District
- East Lake Resource Conservation District; and

WHEREAS, the Parties desire that the proposed Consolidation be subject to the following terms and conditions of the consolidation are set forth herein:

- a. The name of the consolidated RCD (successor district) shall be the Lake County Resource Conservation District.
- b. The consolidated RCD is intended to achieve greater economy and efficiency in providing RCD services for resource conservation issues. The Parties have determined that it is in the best interest of the Parties to consolidate in order to provide better service to the residents of the consolidated RCD.
- c. Pursuant to the provisions of California Public Resources Code section 9301.1, the Board of Directors of the consolidated RCD shall be composed of seven members appointed by the Board of Supervisors for overlapping four-year terms, as provided by law. The seven members of the consolidated Board of Directors shall consist of (1) one Director from each Supervisorial District; (2) two additional "at-large" Directors; and (3) no one Supervisorial District shall be represented by more than two Directors. In the event that the initial Lake County RCD Board does not reflect these requirements, then the initial RCD Board will be comprised of members of both prior boards willing to continue in the capacity of Director. The Lake County RCD Board will endeavor to fill vacancies to obtain the required composition.
- d. All assets, unrestricted, restricted or fiduciary, held by the Parties, shall be transferred to and become assets of the consolidated RCD. The consolidated RCD shall be the successor agency to the Parties. The assets include, but are not limited to water tank, computers and programs, GPS units, office equipment, chain saws and other tools, display panel, demonstration table and cash assets.
- e. All liabilities of the Parties shall be transferred to and become liabilities of the consolidated RCD.
- f. The effective date of the Consolidation shall be the date of recordation of the Certificate of Completion of the consolidation by Lake LAFCo.
- g. Distribution of Services: The newly-formed Board of Directors of the consolidated RCD will authorize an annual work plan for services throughout the consolidated RCD
- h. The Lake County Resource Conservation District shall establish two service zones, areas of benefit, and/or such other structure as may be necessary to ensure that the debts and obligations of the respective Dissolved Districts are borne by the customers residing in the territory of the Dissolved District which incurred the debt or obligation. The service zones, areas of benefit, or other structures shall correspond to the existing service territory of the Dissolved East Lake Resource Conservation District and Dissolved West Lake Resource Conservation District as identified in Exhibits B-1 and C-1 (legal descriptions) and Exhibits B-2 and C-2 (maps); and
- i. The sphere of influence for the Lake County Resource Conservation District shall be coterminous with the approved Lake County Resource Conservation District boundary, described above.

WHEREAS, the Parties hereby consent to the proposed Consolidation without election by the registered voters within their respective Districts and request a waiver of conducting authority proceedings; and

WHEREAS, the Parties find that the proposed Consolidation is categorically exempt from the California Environmental Quality Act ("CEQA") by virtue of Section 15320 of the State CEQA Guidelines (Class 20 Exemption) because the proposed Consolidation is a reorganization of local government agencies where the changes do not change the geographic area in which previously existing powers are exercised;

NOW, THEREFORE, the Boards of Directors of the East Lake RCD and the West Lake RCD hereby find, determine, declare, resolve and order as follows:

- a. The foregoing recitals are true and correct and are adopted as hereinabove set forth.
- b. Lake LAFCo is requested to undertake proceedings for the proposed Consolidation according to the terms and conditions stated above and in the manner provided in the Cortese-Knox-Hertzberg Act.
- c. The President of the Board for each Party is authorized and directed to execute this Concurrent Resolution and any other documents as Lake LAFCo may reasonably request to accomplish the consolidation initiated by this Concurrent Resolution upon affirmative Board vote.
- d. The Boards of Directors of the Parties shall be, and are hereby, authorized and directed to perform any and all acts required to effect the consolidation initiated by this Concurrent Resolution, including, but not limited to preparation and coordination of the application to Lake LAFCo.

1. Enumerate and describe the services to be excluded to the affected territory.

Resource Conservation Districts are authorized to control runoff, prevent or control soil erosion, the development and distribution of water, and the improvement of land capabilities as well as to provide conservation services to protect soil productivity, water quality and air quality and wildlife habitat by conserving and restoring wetlands, habitat, groundwater resource protection and assisting residents and landowners with conservation practices. Resource Conservation Services within the newly consolidated district will be in accordance with the District's annual work program and strategic plan, as amended from time to time.

2. Specify the level and range of those services.

Specifically, the services are to be provided within the district territory in accordance with the district's strategic plan to be developed immediately after formation.

3. Indicate when those services can feasibly be extended to the affected territory.

The services will provided throughout Lake County

4. Indicate any improvements or other conditions the local agency would impose or require within the affected territory if the change of organization or reorganization is completed.

The entire district area will have a voice in the formation of the county-wide annual work plan and amendments to the work plan.



Resolution 2016-0006 of the Lake Local Agency Formation Commission

A Resolution Making Determinations and Approving the Dissolution of the East Lake and West Lake RCDs and Concurrent Formation of the Lake County Resource

Conservation District

WHEREAS, A Concurrent Resolution of Application from the East Lake and West Lake RCDs for the dissolution of the East Lake and West Lake RCDs and the formation of the Lake County Resource Conservation District, as defined in the California Public Resources Code Division 9 Section 9001 et seq., has been filed with the Executive Officer of the Lake Local Agency Formation Commission, California and said application complied with all the requirements of law and the Commission; and,

WHEREAS, The East Lake RCD receives a portion of the property tax revenue in Lake County whereas the West Lake RCD does not; and

WHEREAS, the proceedings for the district dissolutions and formations are governed by the Cortese-Knox-Hertzberg Local Government Reorganization Act, Section 56000 *et seq.* of the Government Code; and

WHEREAS, it is the desire of the East Lake and West Lake RCDs that the territory currently served within these districts be included into the newly formed Lake County Resource Conservation District, which consists of the entire Lake County; and

WHEREAS, at the time and in the manner provided by law, the Executive Officer gave notice of the date, time, and place of a public hearing by the Commission upon said application; and

WHEREAS, the Lake Local Agency Formation Commission has adopted a new Sphere of Influence consistent with the formation of the new Lake County Resource Conservation District, and no new Sphere of Influence update is required at this time; and

WHEREAS, the Executive Officer has reviewed the application and has prepared a report including staff recommendations thereon within the time required by law and has furnished copies of said report to the Commission and to all other persons required by law to receive it; and

WHEREAS, at a hearing on March 16, 2016, the Commission considered the proposal and the report of the Executive Officer; the factors determined by the Commission to be relevant to this proposal, including, but not limited to, factors specified in Government Code Section 56668; and all other relevant evidence and information presented at said hearing, including the comments of all interested parties desiring to be heard; and

WHEREAS, LAFCo, on behalf of the two districts, both districts prepared and certified as the Lead Agency a Notice of Exemption for LAFCO Project # 2014-0003 for the affected territory pursuant to the requirements of the California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code).

NOW, THEREFORE, IT IS HEREBY RESOLVED, DETERMINED AND ORDERED by the Lake Local Agency Formation Commission as follows:

- 1. The foregoing recitals are true and correct.
- 2. The territory comprises the entire Lake County and is found to be inhabited.
- 3. The change of organization is assigned the following distinctive short-term designation: LAFCo File 2014-0003 Lake County Resource Conservation District—Formation
- 4. The name of the consolidated RCD (successor district) shall be the "Lake County Resource Conservation District"
- 5. The Commission has reviewed and considered the information contained in the Notice of Exemption prepared for the Lake County Resource Conservation District for this change of organization and makes a specific determination that this environmental determination adequately addresses this change of organization. The Commission hereby affirms and incorporates this decision and directs staff to file a LAFCo Notice of Exemption as shown in Exhibit A. The applicant agencies shall be responsible for payment of any applicable documentary handling fees required by the Lake County Clerk or filing office.
- 6. The proposed Lake County Resource Conservation District is consistent with and coterminous with the existing East Lake and West Lake Resource Conservation Districts and does not conflict with any other agency providing similar services.
- 7. The Commission adopts the determinations regarding consistency with LAFCO policies contained in the Executive Officer's report for this project dated March 16, 2016 and incorporates them by reference herein.
- 8. The East Lake and West Lake RCDs were formed pursuant to Section 9001 *et. seq.* of the Public Resources Code) are hereby both dissolved and the successor district shall be the Lake County Resource Conservation District.
- 9. This change of organization includes all the territory shown in Exhibit "B -1" Lake County Resource Conservation District Map. The boundaries of the district, as set forth in the proposal, are hereby approved as described in Exhibit "C-1" attached hereto and by this reference incorporated herein.

- 10. The effective date of formation shall be upon the recordation of the Certificate of Completion and after the completion of all proceedings.
- 11. The Lake County Resource Conservation District shall be the successor agency to all rights, responsibilities, properties, contracts, assets and liabilities, and functions of the East Lake Resource Conservation District and the West Lake Resource Conservation District. Any professional service agreements and individual employments contracts will be evaluated consistent with the provisions as follows:

Any full-time or part-time employees of the dissolved East Lake and West Lake RCDs shall become full-time or part-time employees of the successor agency with retention of salaries, seniority rights, vacation/sick leave accruals and accrual rates, retirement and other employee benefits applicable to the dissolved districts. Contract employees and professional service agreements will be evaluated, at the sole and exclusive discretion of the governing body of the newly formed Lake County Resource Conservation District, to determine whether they are essential to the ongoing operation of the District.

- 12. The successor agency shall function under and carry out all authorized duties and responsibilities assigned to a Resource Conservation District as outlined in the Section 9151 of the Public Resources Code and other applicable laws.
- The provisional appropriation limit of the Lake County Resource 13. Conservation District shall be set in the amount as determined by the Lake LAFCo for the first full fiscal year. This amount is to be set from the proceeds of taxes currently received by the East Lake County Resource Conservation District. As stated in Government Code section 56811, the permanent appropriations limit of the district shall be set at the first district election that is held following the first full fiscal year of operation. To the extent the district does not receive tax revenue the Lake County Resource Conservation District will be exempt from this requirement. The provisional appropriations limit for the Lake County RCD shall be \$19,849.00 or the total amount of tax revenues as determined by the Lake County Auditor's office for the current fiscal year. Pursuant to Section 7902.7 and Article XIIIB of the State Constitution, the Districts are directed to adjust their 2015-2016 appropriations limits as appropriate based on the change in the County's population, as determined necessary.
- 14. The Lake County Resource Conservation District shall establish two service zones "Zones of Benefit", as necessary to ensure that the debts and obligations of the respective Dissolved Districts are borne by the customers residing in the territory of the Dissolved District, which incurred the debt or obligation. The "Zones of Benefit" shall correspond

to the existing service territory of the Dissolved East Lake Resource Conservation District (Zone of Benefit 1) and Dissolved West Lake Resource Conservation District (Zone of Benefit 2) as identified in Exhibits B-2 (map) and C-2 (boundary description) and Exhibits B-3 (map) and C-3 (boundary description) respectively.

- 15. As applicable, all income from taxes, assessments or any other source, which has been a continuing right to tax distribution, or historical distribution or allocation of funds to each of the Districts to be reorganized, shall continue to be distributed to either Zone of Benefit 1 (East Lake Zone) or Zone of Benefit 2 (West Lake Zone) of the Lake County Resource Conservation District.
- 16. Any existing bonded indebtedness affected by this change of organization shall remain with either Zone of Benefit 1 or Zone of Benefit 2, as applicable.
- 17. All Assets, unrestricted, restricted or fiduciary, held by the East Lake and the West Lake RCD's, shall be transferred to and become assets of the consolidated RCD. The consolidated RCD shall be the successor agency to both RCDs. The assets include, but are not limited to the water tank, electronic equipment, the chipper and dump truck, office equipment, chain saws and other tools, demonstration table and trailer pump and engine equipment, and cash assets.
- 18. Any previously authorized charges, fees, assessments, and/or taxes currently in effect, now levied or collected by each district, including improvement or assessment districts thereof, shall continue to be levied and collected by the successor Lake County Resource Conservation District.
- 19. All liabilities of the East Lake and the West Lake RCD's shall be transferred to and become liabilities of the consolidated RCD (e.g. the Lake County RCD).
- 20. Pursuant to Public Resources Code Sections 9301.1 *et.seq.* the initial Board of Directors for the consolidated RCD shall be composed of seven (7) members appointed by the Lake County Board of Supervisors for overlapping (staggered) four-year (4) terms, as provided by law. The seven members of the consolidated Board of Directors shall consist of:
 - a. One Director from each of the 5 Supervisorial Districts;
 - b. Two additional Directors shall be appointed "at large"; and
 - c. Not more than two RCD Directors shall reside within one Supervisorial District.

To achieve this, three of the seven directors appointed by the Board of Supervisors shall serve an initial two-year term and the initial Board of

Directors may choose to fill future vacancies either by election or appointment pursuant to Public Resources Code Section 9314.

The Board of Supervisors is requested to make the appointments within six months of the recordation of the Certificate of Completion for the RCD consolidation.

An interim RCD Board shall be comprised of members of both prior boards (East Lake and West Lake RCD's) willing to continue in the capacity of Director. The Lake County RCD Board will endeavor to work with the Board of Supervisors to fill vacancies to obtain the required composition. All directors shall reside within the Lake County Resource Conservation District Boundaries.

- 21. The district shall provide the range of services authorized by the Resource Conservation District Law, commencing at Section 9001 of the California Public Resources Code. The newly created Board of Directors of the Lake County RCD shall authorize an annual work plan for services throughout the consolidated Lake County RCD.
- 22. The Sphere of Influence adopted by Lake LAFCo (Resolution 2014-0006) on July 16, 2014 shall guide the Lake County Resource Conservation District and any Sphere of Influence Updates shall be required per Government Code 56425 (g).
- 23. Further protest proceedings are not waived and the Commission orders a protest proceeding to be conducted. The Commission hereby directs the Executive Officer to schedule a protest hearing for this matter after the expiration of the reconsideration period as specified by Gov. Code Section 56895 and to take action including notice as appropriate in accordance with LAFCo Policies and the requirements of Chapter 3, Part 4 of Division 3 of the California Government Code.
- 24. Five sets of copies of all final exhibit maps, two 8 1/2 reductions of all maps and electronic copies as well as five sets of copies of all final boundary descriptions and maps with suitable clarity for recording at the Lake County Recorder's office shall be submitted to LAFCO prior to the recordation of the Certificate of Completion.
- 25. Notwithstanding the effective date, the boundary descriptions and maps for the district boundary and zones of benefit, if rejected by the State Board of Equalization or if amended by LAFCO for any reason, will be revised at the expense of the applicant Resource Conservation Districts). The Resource Conservation Districts shall be responsible for any associated costs.
- 26. Approval of this reorganization is conditioned upon the applicant's obligation to defend, indemnify, and hold harmless the Lake County Local

Agency Formation Commission and its agents, officers and employees from any claim, action or proceeding against the Commission or its agents, officers, and employees; including all costs, attorney's fees, expenses and liabilities incurred in the defense of such claim, action, or proceeding to attack, set aside, or void the approval or determinations of this Commission concerning this annexation. The Lake Local Agency Formation Commission shall promptly notify the applicant of any such claim, action, or proceeding and be entitled to representation by counsel of its choosing.

- 27. Unless otherwise waived, all LAFCO, Lake County and State of California fees must be paid in full prior to filing the Certificate of Completion. LAFCO will forward invoices and (or) a list of estimated required fees or deposits to the agency prior to filing the Certificate of Completion.
- 28. The Executive Officer is hereby directed to transmit a certified copy of this resolution to each affected agency, as provided in G.C. Section 56882.
- 29. The Executive Officer is directed to record a Certificate of Completion for this proposal upon completion of all proceedings.
- 30. Completion of proceedings shall be concluded within one year after adoption of this resolution. If the proceedings are not concluded within one year after passage of this resolution, all proceedings shall be terminated.






