Disclosure & Disqualification Requirements

Any person or group of persons acting in concert who directly or indirectly contribute \$1,000 or more in support of or in opposition to a change of organization or reorganization that has been submitted to Lake LAFCO must comply with the disclosure requirements of the Political Reform Act of 1974 applicable to local initiative measures to be submitted to the electorate. These requirements contain provisions for making disclosures of contributions and expenditures at specified intervals; they may be reviewed at Government Code §§56700.1 and 81000 et seq. Additional information about the requirements pertaining to local initiative measures to be presented to the electorate can be obtained by calling the Fair Political Practices Commission at (916) 322-5660.

A LAFCO Commissioner must disqualify herself or himself from voting on an application involving an "entitlement for use" (such as an annexation or sphere amendment) if, within the last twelve months, the Commissioner has received \$250 or more in campaign contributions from the applicant, any financially interested person who actively supports or opposes the application, or an agency (such as an attorney, engineer, or planning consultant) representing the applicant or an interested party. The law (Government Code Section 84308) also requires any applicant or other participant in a LAFCO proceeding to disclose the contribution amount and name of the recipient Commissioner on the official record of the proceeding.

Motion carried.

8. 2018 Biennial Review - LAFCo's Conflict of Interest Code

a. Motion by Commissioner Robey, seconded by Commissioner Simon to authorize the Chair to sign Lake LAFCo Biennial Review Form and submit to Code reviewing body, with no amendments. Motion carried: All yes.

9. Discussion regarding LAFCo's Legislative Intent

EO stated that rather than presenting the LAFCo 101 information that he has previously used to educate new and existing Commissioners, this year he is going to breakdown the information on LAFCo laws into segments to be presented at each meeting to allow for a more comprehensive review and discussion. Today's session focuses on LAFCo's legislative intent. EO reviewed Chapter 1 of Title 56000 of the Cortese-Knox-Hertzberg Act, Legislative Findings and Declarations. He also spoke to the history of LAFCo, how and why it was formed, and provided some anecdotal Lake County examples.

10. Executive Officer's report

- a. Kelseyville CWD MSR and SOI: Should have MSR for Commission review at next meeting.
- b. Lake County Lighting Districts MSR and SOI in process Mark Dellinger will assist.
- c. Cobb Reorganization

EO updated Commission on the Cobb Reorganization. Commissioner Robey asked when the reorganization will be finished. Ms. Coppinger responded that the administrative reorganization is well in place and Cobb Area Water is now managing all the water systems that it took in. The State is working on funding for some of the system infrastructures that were in very bad shape. She noted that there is still much work to be done, but the consolidation process went smoothly and much faster than expected.

 Ms. Coppinger also reported on the status of the consolidation of Clearlake Oaks County Water District and CSA 16. She stated there are some issues that need to be resolved. The primary hold up is with PG &E, who are understandably behind due to the fires. Ms. Coppinger stated that she communicates with PG & E at least once a week for updates. Further, the consolidation will not take place until PG & E's work is completed. She stated that she does not anticipate another extension and that the project should be completed by January 2019 as planned.

- EO reported that Hidden Valley Lakes Community Service District and Lake County have been asked to participate in the Civics Peak Water Project. EO will provide additional information at the next meeting.
- Long Term Water Conservation Legislation. SB 606 and SB 1668 were passed. EO expressed concerns at the legislation, noting many outstanding issues. David Cowan is the new Water Resources Manager for Lake County. EO to contact Mr. Cowan to invite him to address the Commission on these issues.
- EO asked chair to sign letter in support of AB 258. Mr. Browne stated that the Governor did not sign the bill because it was not put forward as an appropriation bill, making the support letter unnecessary.
- d. CALAFCo Conference. EO did not have anything new to report.

11. LAFCo Counsel's Report

Mr. Browne will present a session on CEQA and CEQA Exemptions at the next meeting.

12. Commissioner Reports

Chairman Sabatier asked about the Golden State Water District, which the Commission had previously discussed. At the time, it was noted that some information was being gathered in the Oroville area relative to Golden State Water District and the Commission had agreed that the matter should be discussed at a future meeting. Chairman Sabatier asked if the Commission could do an MSR on the four Clearlake Water Districts to review the differences in cost. Mr. Browne stated that Golden State is a private company and LAFCo's direct jurisdiction is over the public agencies. However, he noted that does not prevent the Commission from conducting an MSR to assess the benefits of consolidation of public and private water service providers in the Clearlake area.

Mr. Browne stated that the cost of the Golden State Water District rate study in Oroville was about \$35,000. Ms. Coppinger stated that there has been some discussion-stage meetings currently being held regarding private and public water agencies consolidating. The discussions focus on private company efforts to take in or take over the public agency providers. Ms. Coppinger noted that Michelle Frederick (SWRCB) has also been in the discussion loop.

Mr. Browne asked that LAFCo be included on the notification list for future meetings. Ms. Coppinger stated that LAFCo would be notified.

Commissioner Simon asked Ms. Coppinger about the fourteen customers on Socrates Mine Road who rely on a small water system. Ms. Coppinger stated that those customers recently entered into an agreement for two years of service, so

they have two years to come up with a permanent water service solution. The fourteen customers are next to the Anderson Springs Water District and there is an opportunity for consolidation there.

56021. "Change of organization" means any of the following:

- (a) A city incorporation.
- (b) A district formation.
- (c) An annexation to a city.
- (d) An annexation to a district.
- (e) A detachment from a city.
- (f) A detachment from a district.
- (g) A disincorporation of a city.
- (h) A district dissolution.
- (i) A consolidation of cities.
- (j) A consolidation of special districts.
- (k) A merger of a city and a district.
- (1) Establishment of a subsidiary district.
- (m) The exercise of new or different functions or classes of services, or divestiture of the power to provide particular functions or classes of services, within all or part of the jurisdictional boundaries of a special district as provided in Article 1.5 (commencing with Section 56824.10) of Chapter 5 of Part 3 of this division).

56023. "City" means any incorporated chartered or general law city, including any city the name of which includes the word "town."

56024. "City council" means the legislative body or governing board of a city.

56025. "City officer" means the mayor or a member of the city council.

56026. "Clerk" means the clerk or secretary of a commission, county, city, or district, or the clerk or secretary of the legislative body of a county, city, or district. Where the office of county clerk is separate from the office of the clerk of the board of supervisors, "clerk" means the clerk of the board of supervisors. Where the office of county clerk is separate from the office of the registrar of voters, "clerk" means the registrar of voters with respect to all duties pertaining to the conduct of elections and the county clerk with respect to all other duties.

56034. "Disincorporation" means the dissolution, extinguishment, or termination of the existence of a city and the cessation of its corporate powers, except for the purpose of winding up the affairs of the city.

"Dissolution"


56035. "Dissolution" means the disincorporation, extinguishment, or termination of the existence of a district and the cessation of all its corporate powers, except as the commission may otherwise provide pursuant to Section 56886 or for the purpose of winding up the affairs of the district.

"District" or "special district"

- **56036**. (a) "District" or "special district" are synonymous and mean an agency of the state, formed pursuant to general law or special act, for the local performance of governmental or proprietary functions within limited boundaries and in areas outside district boundaries when authorized by the commission pursuant to Section 56133.
- (b) "District" or "special district" includes a county service area, but excludes all of the following:
 - (1) The state.
 - (2) A county.
 - (3) A city.
 - (4) A school district or a community college district.
 - (5) An assessment district or special assessment district.
 - (6) An improvement district.
- (7) A community facilities district formed pursuant to the Mello-Roos Community Facilities Act of 1982, (Chapter 2.5 (commencing with Section 53311) of Part 1 of Division 2 of Title 5).
- (8) A permanent road division formed pursuant to Article 3 (commencing with Section 1160) of Chapter 4 of Division 2 of the Streets and Highways Code.
- (9) An air pollution control district or an air quality maintenance district.
- (10) A zone of any special district.

Change of organization; principal act

- 56036.5. (a) For the purposes of Chapter 1 (commencing with Section 57000) to Chapter 7 (commencing with Section 57176), inclusive, of Part 4 or Part 5 (commencing with Section 57300), for each of the following entities proceedings for a change of organization shall be conducted pursuant to the principal act authorizing the establishment of that district:
- (1) A unified or union high school library district.
- (2) A bridge and highway district.
- (3) A joint highway district.
- (4) A transit or rapid transit district.



- (5) A metropolitan water district.
- (6) A separation of grade district.
- (7) For other districts, where the principal act provides, the procedures in the principal act shall supersede the procedures set forth in this division.

56036.6. (a) For the purposes of Chapter 1 (commencing with Section 57000) to Chapter 7 (commencing with Section 57176), inclusive, of Part 4 or Part 5 (commencing with Section 57300), none of the following entities is a "district" or "special district" if the commission of the principal county determines, in accordance with Section 56127 and 56128, that the entity is not a "district" or "special district":

- (1) A flood control district.
- (2) A flood control and floodwater conservation district.
- (3) A flood control and water conservation district.
- (4) A conservation district.
- (5) A water conservation district.
- (6) A water replenishment district.
- (7) The Orange County Water District.
- (8) A California water storage district.
- (9) A water agency.
- (10) A county water authority or a water authority.
- (b) If the commission determines that an entity described in this section is not a "district" or "special district," any proceedings pursuant to Part 4 (commencing with Section 57000) for a change of organization involving the entity shall be conducted pursuant to the principal act authorizing the establishment of that entity.

"Divestiture of power"

56037.2. "Divestiture of power" means the termination of the power and authority to provide particular functions or classes of services within all or part of the jurisdictional boundaries of a special district.

"Elections official"

56037.5. "Elections official" shall have the same meaning as in Section 320 of the Elections Code.

"Executive officer"

56038. "Executive officer" means the person appointed by a commission pursuant to Section 56384.

"Feasible"

56038.5. "Feasible" means capable of being accomplished in a successful manner within a reasonable period of time, taking into account economic, legal, social, and technological factors.

SUBJECT: Notification of Inactive Special Districts in County

Dear Mr. Benoit:

Chapter 334, Statutes of 2017, also known as Senate Bill (SB) 448, added various provisions to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 regarding special districts that are inactive. It requires the State Controller's Office (SCO) to create a list of inactive special districts based on information in the special district's Financial Transactions Report (FTR), to publish the list of inactive special districts on its website annually, and to notify the local agency formation commission in the county or counties in which the inactive special district is located.

Pursuant to Government Code (GC) section 56042, an "inactive special district" must:

- Meet the definition set forth in GC section 56036;
- Have no financial transactions in the previous fiscal year; and
- Have no assets, liabilities, outstanding debts, judgments, litigation, contracts, liens, or claims.

Pursuant to GC 56879, within 90 days of receiving this notice, the Commission is required to initiate dissolution of inactive special districts by resolution, unless the Commission determines that a district does not meet the criteria set forth in GC 56042. Additionally, the Commission is required to notify the SCO if it determines that district does not meet the dissolution criteria in GC 56042. Once the dissolution process is complete, please inform the SCO using the contact information on the next page.

The enclosure lists the special districts within your jurisdiction that are inactive, based on financial data in each special district's fiscal year 2016-17 FTR. The complete list of inactive California special districts may be found at:

Government Code (GC) 53895(a) provides a penalty for the districts who didn't submit their financial reports as follows:

- (a) An officer of a local agency who fails or refuses to make and file his or her report within 20 days after receipt of a written notice of the failure from the Controller shall forfeit to the state:
- (1) One thousand dollars (\$1,000), in the case of a local agency with total revenue, in the prior year, of less than one hundred thousand dollars (\$100,000), as reported in the Controller's annual financial reports.
- (2) Two thousand five hundred dollars (\$2,500) in the case of a local agency with total revenue, in the prior year, of at least one hundred thousand dollars (\$100,000) but less than two hundred fifty thousand dollars (\$250,000), as reported in the Controller's annual financial reports.
- (3) Five thousand dollars (\$5,000) in the case of a local agency with total revenue, in the prior year, of at least two hundred fifty thousand dollars (\$250,000), as reported in the Controller's annual financial reports.
- (b) (1) Upon the request of the Controller, the Attorney General shall prosecute an action for the forfeiture in the name of the people of the State of California.
- (2) Upon a satisfactory showing of good cause, the Controller may waive the penalties for late filing provided in this section.
